Chair Report: Eric suggested Webster might use some of the increased budget money to go towards the green space. Planning board supports town funding to go towards enhancements to the greenspace. Eric made a motion at 5:46, that the planning board recommend to the town board that they put some additional funding towards greenspace enhancements. Will seconded the motion.

Planning Board member reports: Leigh Anne reported on the greenway committee survey to prioritize certain projects and the results of that survey. The two main projects in Webster: the Buchanan Loop Connector and the Webster sidewalk gaps.

OLD BUSINESS

1. Reviewed Land Use Plan Draft Discussion included:

- Leigh Anne suggested possibly moving the town of Webster Vision into a box
- Under public health, Eric mentioned there are no significant point sources of air or water health quality impacts in the Webster planning area
- Discussion: Should Webster's offerings overlap with the CDC recommendations and/or maybe move the CDC recommendations to the recommendations section for all of us to discuss whether we want to prioritize those things in the town of Webster?
- Discussion of properties within the 100 year floodplain and Leigh Anne will look into this section a little more.
- Should the further opportunities section be in each section? Or should we just go with recommendations?
- How to make clear that climate and renewable energy, and sustainability is a priority? Solar panels on town hall with gauges could be a good educational tool.
- Discussion of short term rentals and the need to decide how this board feels in regards to this topic. Maybe highlight some questions for the town board to consider?
- ETJ is both blue and residential, is it possible to adjust the map?

- Rock property zoned business? Need to confirm.
- Discuss further the allowed uses for larger parcels.
- Discussion of whether we adopted the steep slope ordinances and any other protective ordinances.
- 2. Executive Summary: Need to decide what should go in this part of the document.

Discussed a goal to have the LUP circulated to the town board by May meeting and will later be launched to the public.
